# 維護國家安全

## Safeguarding National Security

- ▶ 申請機構遞交申請表格時，必須同時遞交**確認書（附錄I）**，以代表其**知悉及承諾遵守下述條款**：
  - 政府保留權利以機構曾經參與、正在參與或有理由相信機構曾經或正在參與可能導致或構成發生危害國家安全罪行的行為或活動為由，**取消其申請資格**；
  - 又或為維護國家安全，或為保障香港的公眾利益、公共道德、公共秩序或公共安全，而有必要**剔除機構日後申請的資格**。
- ▶ Applicant organisation has to submit an Agreement (Annex I) along with the application form, to confirm the organisation has acknowledged and undertaken to comply with the following clauses:-
  - the Government reserves the right to disqualify the recipient organisation on the grounds that it has engaged, is engaging, or is reasonably believed to have engaged or be engaging in acts or activities that are likely to cause or constitute the occurrence of offences endangering national security;
  - or otherwise the exclusion of the organisation from future applications is necessary in the interest of national security, or is necessary to protect the public interest of Hong Kong, public morals, public order or public safety.

# 維護國家安全

## Safeguarding National Security

- ▶ 即使有關申請已獲批准，如果出現下列任何一種情況，政府可**立即撤回或取消有關批准**：
  - 機構曾經參與或正在參與可能會構成或導致發生危害國家安全罪行或不利於國家安全的行為或活動；
  - 繼續委約機構或繼續推行該環境及自然保育基金項目將不利於國家安全；或
  - 政府合理地相信上述任何一種情況將會發生。
- ▶ Even after the application is approved, the Government may immediately withdraw or cancel the relevant approval upon the occurrence of any of the following events:
  - the organisation has engaged or is engaging in acts or activities that are likely to constitute or cause the occurrence of offences endangering national security or which would otherwise be contrary to the interest of national security;
  - the continued engagement of the organisation or the continued implementation of the ECF project is contrary to the interest of national security; or
  - the Government reasonably believes that any of the events mentioned above is about to occur.

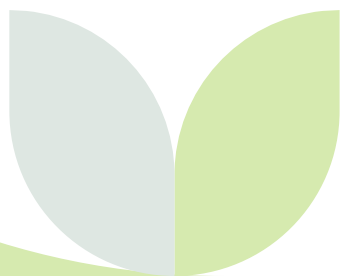

# 智能回收未來發展

Carry out smart recycling projects on application and/or development of artificial intelligence, big data technologies, etc.
- ▶ 進行有助提高社區參與乾淨回收的項目，如利用人工智能辨識回收物及建議合適的回收點，利用大數據預測及評估社區回收支援措施  
Carry out projects that can enhance community participation in clean recycling recognising recyclables and advise on suitable outlets by utilising Artificial Intelligence, predicting and evaluating the effectiveness of community recycling support measures by application of big data analytic, etc.

# 減少即棄塑膠

## Reduction of disposable plastics

- ▶ 運用創新科技 / 高效方法，便利源頭減少使用即棄餐具的**可重用餐具租借 / 中央餐具清潔**的服務計劃、或便利即棄餐具（例如植物纖維餐具）使用後**資源回收及預處理**的服務計劃。

Apply innovative technologies / effective methods in reusable tableware lending programmes / central tableware washing services to facilitate reducing the use of disposable tableware at source, or in recycling programmes to facilitate resource recovery and pre-treatment of used disposable tableware (e.g. plant-fibre based tableware).

Coordination with EPD is required regarding **the food waste delivery arrangement** for the approved projects, if EPD is able to provide the delivery service to the Government treatment facilities, the budget allocated for the associated shall not be used.

# 1 源頭減廢

## Waste Reduction at Source

- ▶ 推動**源頭走塑**、**減少使用即棄**塑膠及**鼓勵使用可重用的**代替品  
Promote the elimination of plastic at source, reduction of disposable plastic and encourage the use of reusable alternatives.



- ▶ 推廣**惜食**文化，鼓勵食肆與顧客共同從源頭減少廚餘。  
To encourage eateries to reduce food waste at source together with customers.



# 管制即棄膠餐具和其他塑膠產品

## Regulation of Disposable Plastic Tableware and Other Plastic Products

為從源頭減少使用即棄塑膠產品，相關條例草案已於2023年10月18日獲立法會通過。為了讓業界做好準備，**第一階段管制**會在六個月的準備期後，於**2024年4月22日開始實施**以分階段管制各類即棄膠餐具和其他塑膠產品。

To reduce the use of disposable plastic products at source, the Amendment Bill was passed by the LegCo on 18 October 2023. To allow time for the trades to get prepared, the first phase regulation will be implemented on 22 April 2024, after the six-month preparation period to regulate disposable plastic tableware and other plastic products in phases.

- 禁止**銷售**及禁止餐飲處所向**外賣**顧客提供**發泡膠餐具、飲管、攪拌棒、叉刀匙和碟**；
- 禁止餐飲處所向**堂食**顧客提供**任何即棄膠餐具(包括杯、杯蓋、食物容器及食物容器蓋)**。

The first phase regulation consists of:

- Prohibits the sale and provision of EPS tableware, straws, stirrers, forks, knives, spoons and plates at catering premises to customers takeaway services;
- Prohibits the provision of any disposable plastic tableware (Including cups, cup lids, food containers and food container covers) to dine-in customers at catering premises.



# 塑膠購物袋收費計劃

## Plastic Shopping Bag (PSB) Charging Scheme

**塑膠購物袋收費**自2015年4月1日起在整個**零售業界全面推行**。為維持計劃的成效，政府於2022年12月31日起推行了以下優化措施：

- 每個膠袋的收費提高至最低**一元**；
- **取消**盛載**冰凍或冷凍食品**的膠袋的**豁免**；以及
- **收緊**盛載**沒有包裝及非氣密食品**的膠袋的豁免，以每單一交易一個免費膠袋為基本原則。



The PSB Charging Scheme has been fully implemented in the entire retail sector since 1 April 2015. To maintain the effectiveness of the Scheme, on 31 December 2022, the Government implemented the following enhancement measures:

- increasing the charging level per PSB to at least \$1;
- removing the exemption for PSBs carrying frozen/chilled foodstuff items; and
- tightening the exemption for PSBs carrying foodstuff items without packaging or in non-airtight packaging, with "one free PSB per single transaction" as the basic principle.

## 分類回收

### Waste Separation and Recycling

- ▶ 環保署致力發展回收網絡，自2015年起開展的「綠在區區」，服務範圍已擴展至全港18區，並統一接收**八類回收物**（即廢紙、金屬、塑膠（包括發泡膠）、玻璃容器、慳電膽／光管、充電電池、小型電器及四電一腦）。除上述八類回收物以外，環保署亦積極推動廚餘回收。

The EPD is sparing no effort in developing the community recycling network. The Green@Community, which started in 2015, serves members of the public territory-wide, and collect eight types of recyclables (namely paper, metals, different types of plastics (including styrofoam), glass containers, fluorescent lamps and tubes, rechargeable batteries, small electrical appliances and regulated waste electrical and electronic equipment). Besides the eight types of recyclables mentioned above, the EPD is also actively promoting food waste recycling.



# 玻璃飲料容器生產者責任計劃

## Producer Responsibility Scheme on Glass Beverage Containers

環保署已於2023年5月1日全面落實玻璃飲料容器生產者責任計劃：

- ❖ 透過公開招標委聘玻璃管理承辦商提供廢玻璃容器收集及處理服務；
- ❖ 向在本港分發或耗用玻璃樽裝飲品的製造商及進口商收取容器循環再造徵費；及
- ❖ 引入牌照制度規管廢玻璃容器的處置，並引入進出口許可證制度以規管進出口廢玻璃容器，確保廢玻璃容器以合乎環保的方式處理。



The EPD has fully implemented the Producer Responsibility Scheme on glass beverage containers since 1 May 2023:

- ❖ Appointing Glass Management Contractors (GMCs) through open tender to provide waste glass container collection and treatment services;
- ❖ Collecting a container recycling levy from manufacturers and importers for glass-bottled beverages that they distribute or consume in Hong Kong; and
- ❖ Introducing licence control on the disposal of waste glass containers and permit control on their import and export to ensure waste glass containers are processed in an environmentally sound manner.



# 塑膠飲料容器生產者責任計劃

## Producer Responsibility Scheme on Plastic Beverage Containers

政府預期最快2025年推行**塑膠飲料容器生產者責任計劃**，要求各相關持份者共同承擔環保責任，**妥善收集和處理塑膠飲料容器**，以轉化成有市場價值的回收物料。此外，計劃建議提供回贈，以鼓勵公眾交回用完的塑膠飲料容器。

The Government proposed to launch Producer Responsibility Scheme on Plastic Beverage Containers in 2025 the earliest, which would require stakeholders to share the environmental responsibilities of collecting and treating plastic beverage containers, thereby turning them into marketable recycled materials. Furthermore, the proposed scheme will include rebates to encourage people to return used plastic beverage containers.



### 3 轉廢為能 Waste-to-Energy

A number of large-scale waste management facilities have been built to support the waste separation work and facilitate the transformation of waste into resources.





# 環保署現有服務

## Existing Services Provided by the EPD

### 路邊回收桶

### Kerbside Recycling Bins



環保署在2022年6月開始逐步**移除市區的路邊回收桶**，以鼓勵市民善用已升級的屋苑 / 住宅大廈及綠在區區社區回收設施。

The EPD has been progressively removing the kerbside recycling bins in urban areas including Southern District since June 2022, and encouraging the public to make good use of the upgraded facilities in housing estates/residential buildings and GREEN@COMMUNITY for recycling.

現時在**鄉郊地區**的公眾地方設置約1,100個**路邊回收桶**，以方便市民回收最常見的3類回收物。

Currently, the EPD has put in place around 1,100 kerb-side recycling bins in public places to facilitate the public to recycle the three most common types of recyclables.

# 綠在區區 GREEN@COMMUNITY

- ▶ 環保署在全港18區設立「回收環保站」、「回收便利點」及「回收流動點」，接收不少於8種回收物，包括廢紙、金屬、塑膠、玻璃樽、四電一腦、小型電器、慳電膽及光管、充電池等，以加強支援地區層面的減廢回收。

To strengthen the support for waste reduction and recycling at the district level, EPD has set up Recycling Stations, Recycling Stores and Recycling Spots across the territory to collect at least eight common types of recyclables, including paper, metals, plastics, glass bottles, regulated electrical equipment, small electrical appliances, fluorescent lamps and tubes, and rechargeable batteries, etc.

現時全港**共有71個回收便利點**（前稱「社區回收中心」）。全新形象的回收便利點大多鄰近缺乏分類回收設施的舊區。各區回收便利點除聖誕及農曆新年假期全年無休，大部份在營業時間後設有夜間自助回收服務，提供「便利」市民的社區回收支援。

There are 71 Recycling Stores (formerly known as "Community Recycling Centers") around the territory. The Recycling Stores with brand new image are mostly located near old districts where waste recovery facilities are limited. Except for Christmas and Lunar New Year holidays, the Recycling Stores are open all year round, most of these Recycling Stores have nighttime recyclable dropping-off service after operating hours, providing "convenient" recycling support to the community.

# 綠展隊

## Green Outreach

- ▶ 為加強實地社區回收支援，環保署成立了綠展隊，深入社區提供外展服務，通過即場指導和現場示範，長期且恆常地教育公眾源頭減廢的重要，鼓勵公眾實踐廢物源頭分類及乾淨回收，宣傳「綠在區區」的服務，以及向社區傳達最新的廢物管理信息。
- ▶ To strengthen on-site recycling support at community level, the EPD set up the Green Outreach to provide outreaching services at the territory. Through on-site guidance and hands-on demonstrations, the Green Outreach regularly educates the public about the importance of waste reduction at source, encourages and facilitates the public to practice source separation of waste and clean recycling, promotes GREEN@COMMUNITY services, and disseminates the latest information on waste management.





# 塑膠回收先導計劃

## Plastic Recycling Pilot Scheme



環保署自2020年1月於三個地區（**東區、觀塘和沙田**）作試點，推行塑膠回收先導計劃，並於2022年3月底起擴展至九區（新增六區為**中西區、深水埗、荃灣、屯門、大埔及西貢**），以服務合約形式聘請承辦商向區內已登記的公私營住宅、學校、公營機構和「綠在區區」等**提供免費收集非工商業廢塑膠服務（包括膠袋、膠容器、膠餐具、發泡膠）**。

EPD has been implementing a Pilot Scheme in three districts (Eastern, Kwun Tong and Sha Tin) since January 2020, and has further extended the Pilot Scheme to nine districts (6 newly added districts are Central and Western, Sham Shui Po, Tsuen Wan, Tuen Mun, Tai Po and Sai Kung) since late March 2022. Contractors are engaged under service contracts to provide free collection service for waste plastics (including plastic bags, plastic containers, plastic tableware, polyfoam) from registered premises for non-commercial and non-industrial sources such as public and private housing estates, schools and public institutions and GREEN@COMMUNITY in the districts.

# 入樽機先導計劃

## RVM Pilot Scheme

為配合日後推出「塑膠飲料容器生產者責任計劃」，環保署於2021年第一季推出**入樽機先導計劃**，於公眾地方或政府設施等地點，設置共60部入樽機，並透過電子支付平台提供即時回贈，以**鼓勵公眾交回使用完的塑膠飲料容器**。第二期先導計劃於2022年第二季推出，入樽機的數目會分階段逐步**增加至合共120部**。第三期先導計劃於2023年12月推出，繼續為市民提供更優化的入樽機服務。社區上亦有一些機構設置了入樽機供市民使用。

To pave the way for the future implementation of the Producer Responsibility Scheme on Plastic Beverage Containers, EPD has rolled out a RVM Pilot Scheme in the first quarter of 2021. 60 RVMs were installed at locations such as public places or government facilities, with provision of instant rebate via e-payment platform to encourage the public to return their used plastic beverage containers. Stage 2 of the pilot scheme was launched in the second quarter of 2022 with the number of RVMs increased progressively to 120 in phases. Stage 3 of the pilot scheme commences in December 2023, and continue to provide enhanced RVM services to the public. There are also some organisations in the community that have set up RVMs for public use.

# 玻璃飲料容器回收服務

## Recycling Service for Glass Beverage Containers

作為「玻璃飲料容器生產者責任計劃」的一環，政府已委聘**玻璃管理承辦商**，**為全港提供廢玻璃容器收集及處理服務**。玻璃管理承辦商須在所負責的區域建立玻璃樽回收點網絡，為區內的工商業處所（例如酒吧及食肆）及住宅樓宇和屋苑提供玻璃樽收集服務。由玻璃管理承辦商提供的收集服務，費用全免。

As part of the Producer Responsibility Scheme on Glass Beverage Containers, the Government has appointed GMCs to provide collection and treatment services covering the territory for waste glass containers. The GMCs are required to set up within their catchment regions a network of collection points for glass bottles serving commercial and industrial establishments such as pubs and food premises, as well as residential buildings and estates. The collection services provided by the GMCs are free of charge.

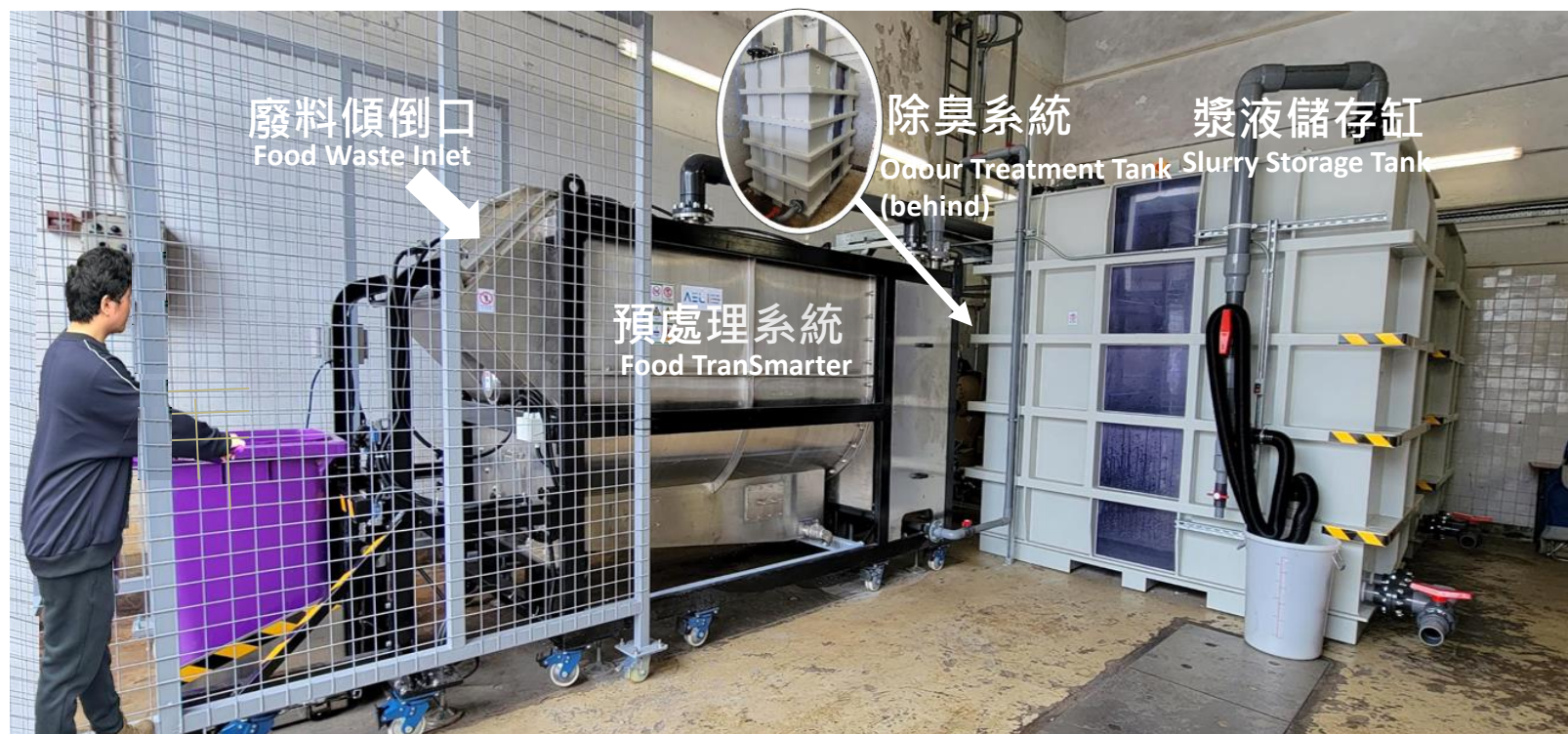

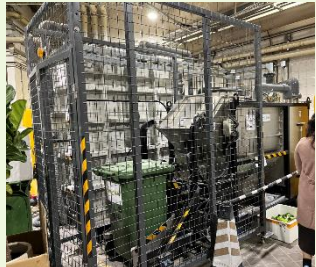

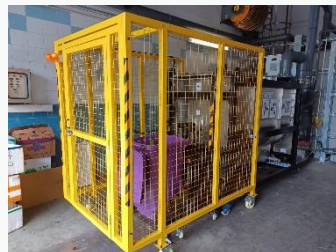

## Main Reasons for Supporting the Applications



- ✓ 項目富創意，能**與政府政策互相呼應**，並**與社區上現有的活動或服務沒有重疊**。

The project is creative, echoes the theme of government policies, and not duplicating with the activities or services in the community.



- ✓ 有**周詳的計劃**（如詳述回收物的出路、有效的宣傳方法），且推行**時間表合理可行**。

The project is well-planned (e.g. with details on recyclable outlets, effective promotion plan) and the implementation plan is reasonably practicable.

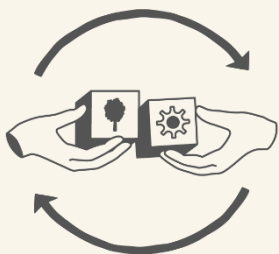

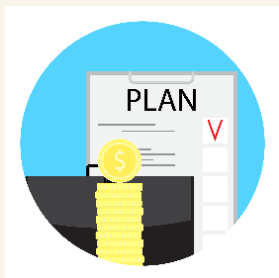

Support from organisations with relevant professional knowledge / community had been confirmed.

# 申請不獲資助的主要原因

## Main Reasons for Not Supporting the Applications

- X **未有遞交完整的申請**表格 / 必要的相關文件。  
Incomplete application form and/or required documents are not submitted.
- X 項目**延續多於兩次**。  
Already extended for more than twice if it is an application for extension.
- X 申請機構在同一資助計劃下**同時有兩個正在進行的資助項目**，而該些項目的**項目期**與新申請的項目期有所**重疊**。  
The applicant organisation already has two on-going projects under the same funding scheme, of which the project periods overlap with the proposed project period of the new application.
- X 申請機構**過往項目成效欠佳**及 / 或**經常遲交報告書**。  
The applicant organisation has unsatisfactory performance and/or frequent delay in report(s) submission in their past project(s).

# 申請不獲資助的主要原因

## Main Reasons for Not Supporting the Applications

- X **重複**其他機構 / 團體 / 政府部門正進行的工作或活動。  
Repeat work or activities conducting by other organisations/groups/government.
- X 項目計劃**不完善及空泛**，活動**內容渙散**，未能充份帶出項目主題。  
The project proposal is not comprehensive and too brief. The project activities are unfocused and fail to bring out the project theme fully.
- X **減廢及回收**元素**薄弱**。  
The elements of waste reduction and recycling is weak.
- X 項目側重舉辦**一次性 / 單一活動**（如嘉年華），或未能有效引導參加者作出行為改變保護環境。  
The project focuses on organising one-time or a single activity (e.g. carnival) which may not be effective in guiding participants to induce behavioral changes for environmental protection.

## Main Reasons for Not Supporting the Applications

The activities do not align with the objectives of the project.

The proposed budget is too high and not cost-effective.
- X 申請機構**未能顯示具專業環保知識**。  
The applicant organisation does not possess professional environmental knowledge.

- ▶ The Government may immediately terminate any agreement with the organisation upon the occurrence of any of the following events:
  - the organisation has engaged or is engaging in acts or activities that are likely to constitute or cause the occurrence of offences endangering national security or which would otherwise be contrary to the interest of national security;
  - the continued engagement of the organisation or the continued implementation of the ECF project is contrary to the interest of national security; or
  - the Government reasonably believes that any of the events mentioned above is about to occur.
